#### About Us

Family is at the heart of who we are and what we do. **Noelle's Light** was created by two parents' love for their late daughter, Noelle, who was born and died in 2016 of complications from a rare fetal diagnosis.

Heartbroken but inspired by their experience, Alex & Jodi Laughlin set out to provide hope to other families. Since beginning operations as a 501(c)3 public charity in 2020, Noelle's Light has supported more than 265 families through their financial and emotional support programs, serving families from 21 different US states and 7 countries around the world. Our emergency financial relief grants have provided \$275,000+ to families facing crisis, helping cover mounting costs such as rent & mortgage payments, travel costs, lost wages from time off work, and far too often, funeral expenses for their baby. Noelle's Light is currently partnered with *Children's Hospital of Philadelphia*, *Ronald McDonald House Philadelphia*, and *Ronald McDonald House New York*, and now working closely with *Boston Children's Hospital* and *UVA Children's Hospital*.

"For many parents, starting or growing a family can lead to emotional, physical, and financial mountains that they are unable to climb alone. Noelle's Light supports them in their moment of need."

Our mission is to support families receiving treatment or care for a life-threatening fetal diagnosis. The families we serve are either actively pregnant with a fetal diagnosis, have a born child in the NICU under the age of 12 months, or have experienced miscarriage, stillbirth, or infant loss due to a fetal or congenital condition. Our services include financial support, mentorship, and resources.

Proceeds from the 3<sup>rd</sup> Annual Noelle's Light Golf Classic will expand our mission to reach more families in 2024 than ever before. No parent should worry about where to turn for help or how to keep their bills paid while caring for themselves or their child. Instead, they should feel supported, heard, and loved by people that realize our strength as a community is only as strong as the families within it.
